

Is Israel violating international law?

1917: The Balfour Declaration: A homeland of the Jewish people shall be created.

1919: Versailles Declaration: Also Arab delegate (Arab emir) acknowledges the Jews' right to a homeland. (Emir Feisal and Zionist leader Weisman present, not U.S. delegate).

April 1920: Treaty of San Remo. All allies after the 1st World War were present. Legal binding. Content: The Jews consist of one people with own religion, language and common ethnic and historical background.

The Jews are the indigenous people of the area in the heart of the Mediterranean. (The Palestinians of today were not mentioned, as they did not exist. "Palestine" has never been a own country with its own people, language, history and so on.

The treaty drew up guidelines for the development of the lands they Allies liberated during World War 1. Here focus on the Ottoman Empire.

The Treaty of San Remo was legal binding court settlement after 1. world war.

1922: The League of Nations is established to prevent war in the world. (Precursor to the UN).

July 1922: The League of Nations appoints The Palestine Mandate. The British are given responsibility for the development up to 14 May 1948, and calls the area the Palestinian Mandate. (France gets Syria/Lebanon-area).

Decision: Article 6 states, among other things Administration for the Palestinian Authority mandate (for the British) to facilitate Jewish immigration, and is intended to encourage dense settlement of Jews in the country, including stateland, outlying areas not needed for public purposes...

Rights and position of other parts of the population (Arabs/Christians) should is not set aside. The Jews are recognized as the indigenous people in the area, (because it was then there was no such thing as a Palestinian-Arab people). **The Treaty of San Remo** will be integrated into the decision.

Demarcation: The League of Nations decides to establish the state of Transjordan on the 3/4 parts of

The Palestine Mandate, i.e. everything land east of the Jordan River. The Jews are said to have all land west of the Jordan River.

Article 6 means that Jews have the right to live close together in all parts of the country west of Jordan River. It goes on to say that other ethnic groups should not be discriminated against in the Jewish homeland.

There is no international body that has or may invalidate the League of Nations' Resolution of 1922. The decision has not been replaced, obsolete or amended 90 years.

November 29, 1947:

The General Assembly of the United Nations proposes that an Arab state no. 22 is established in Judea/Samaria due to uprisings among the Arabs. The international community is succumbing to terror.

But the Arabs say no thanks to a state in Judea/Samaria (West Bank), thus the Security Council cannot adopt the proposal, and the area is legally back to decision of 1920 and 1922.

Article 80 of the UN Charter states that: rights as states and peoples in the past are granted in international law agreements, not be amended by the provisions of the UN Charter without the consent of the parties.

May 14, 1948: The British Mandate period is over, and the Jews are free to establish their state.

War: Transjordan enters and takes Judea/Samaria and annexes it in 1951. UN declares this to be invalid. Transjordan give themselves a different name: Jordan, as they now are in possession of land also west of Jordan River. The Jews of Judea/Samaria/Jerusalem is being chased out. More Arabs comes in.

Egypt occupied the Gaza Strip. Contrary to international law.

The 6-Day War in June 1967: Israel attacked, and now holds the area of Judea/Samaria under administration according to international law before a peace Agreement is reached Entered into. That is why Israel calls the areas for: "Managed Territories." BUT: Israel has chosen to annex Judea/Samaria (West Bank), then international law of 1920 and 1922 are in force. Israel has also chosen to give the Arabs there the right to govern themselves in civilian areas, or relinquishing lands (relinquishing sovereignty).

No one can make an appointment in this area without Israel's acceptance. Resolution 242 of the UN after this war asks the parties to consider "territories" in the war, not "territories" (which refers

to "the green line" which were the territories Transjordan train) in a final peace agreement.

Population displacements: 1948:

The UN adopted that Arabs who had been inside land west of the Jordan River guest workers or other for 2 years or were to have refugee status.

From the newly established Arab states,

It chased out twice as many Jewish refugees to newly established Israel, which the number of Arabs who voluntarily fled from Israel.

Israel has no obligation under international law to Receive those who traveled.

It was the Arab countries that created the war in Israel in 1948.

It should be emphasized that the land of Jordan persists of 78% of "Palestine" (the Palestinian mandate).

Law on indigenous peoples Rights:

United Nations Act of 2007, article 10: See at the bottom of the page.

The PLO was established in 1964, to wipe out Israel (the Arabs was then in possession of Judea/Samaria).

Before this happened, no Arabs wanted to call themselves "Palestinians". In the 1900s it was only the Jews who called themselves Palestinians until 1964.

PLO's goal:

1. No recognition of Israel.
2. Annihilation of Israel.
3. Violence and terrorism will be used to achieve the goal.

This goal has never been discarded of the PLO National Council. Arafat had not the PLO National Council's acceptance when he signed the Oslo Agreement on the lawn in front of the White House.

Both Hamas and the PLO aim to: destroy Israel. But the PLO says otherwise to the West than to their own. Hamas does not hide his goal towards West.

Israel has made an agreement (the Oslo Agreements 1993 and 1995) with the PLO (PA) on A, B, and C areas in Judea/Samaria.

A: Independent government without foreign and defense tasks for the Arabs.

B: Own civil and religious rights to Arabs.

C: Israeli territories.

Decision whether this will not be ratified until finally peace agreement. The Arabs have chased out everyone the Jews in the A and B areas. The West is silent.

PLO continues to work for recognition of a state. Uses requirements and methods such as contravenes international law (unilaterally goes to the UN for acceptance of a state, lies about their connection to the country, destroys evidence linking the Jews to the area, etc.).

Are the Jewish **settlements** in Judea/Samaria contrary to international law? No, it is Western leaders who call for a break on international law. The Indigenous Peoples Act and The League of Nations decision of 1922 applies.

Violates international law by building Fence against enemy areas? No.

Every country has the right to defend itself. **The fence/wall** prevents 95% of the terror attacks from the "West Bank" on Israel.

Violates international law by chasing away **enemy ships** in their own territorial waters? No, it is the Western media that blurs the boundary between legitimate criticism and derogatory mention of Israel. Nobody Flotilla has had international law on its side.

Does Israel have to **release its condemned prisoners**? No!

Western leaders are making a serious breach of the international law by forcing Israel to release condemned prisoners. It also goes against custom and people's sense of justice.

The session in the autumn of 2011 when the PLO was admitted as a **non-member state of the UN** is contrary to international law, because this does not had been negotiated bilaterally by the parties PA - Israel. This is also contrary to The Oslo Accords (Article 31 of the Oslo Accords II) stressing that progress in the negotiations shall take place between the parties; and only between the parties.

It is also contrary to international law to call area under Israel's jurisdiction for "Palestine" before agreement is negotiated by the parties, as Norway is now doing.

Israel has international law on its side they were to annex Judea/Samaria (West Bank). The key is San Remo of 1920 and the League of Nations' decision of 1922. Only Israel can decide on the release of sovereignty of these areas.

No relocation shall take place without a free, prior and informed consent of the indigenous people concerned, and in agreement with the lawful and fair compensation and, where possible, with the possibility of return."
